BDEC is not to be held liable for any losses or damages, whether actual, consequential, punitive, or otherwise, to the Member or anyone claiming by, through, or under the Member related to the failure to deliver this power, as requested, if it is not available or cannot be delivered in a timely manner. All construction charges must be paid and other required paperwork and/or county/state permits must be submitted prior to construction scheduling.
